01 NUMEROUS BOOSTING OPPORTUNITIES FOR EXPLOITING RENEWABLE ENERGY IN VIETNAM

On December 6th 2018, the discussion of "Renewable Energy Boosting in Vietnam" was successfully held by BCG Energy – a subsidiary of Bamboo Capital Group (BCG) – and Tuoi tre

Experts were discussing about difficulties, obstacles of policy issues as well as pricing strategies in investing procedure and the environmental impact of the renewable energy producing process. At the end, practical solutions were put forward with the goal to solve all problems and create more favourable opportunities for businesses by adjusting the selling price of electricity purchased from renewable energy along with policies to encourage people using this clean energy source.

02 BAMBOO CAPITAL GROUP ATTENDING THE INVESTMENT COOPERATION SEMINAR WITH THE ASIAN BUSINESS ALLIANCE (ABA) IN KOREA

On December 19th, 2018 in Seoul, South Korea, the chairman of Bamboo Capital Group (BCG) – Mr Nguyen Ho Nam attended the Investment Cooperation Seminar with the Asian Business Alliance (ABA). The seminar attracted more than 350 Korean enterprises, opened up more potential cooperating investment opportunities with BCG in key areas such as Real Estate, Renewable Energy, Construction and Coffee Commercial with Organic fertilizer. During the working trip in Korea, on December 20th, 2018, Vinacafe Fertilizer JSC – a subsidiary of BCG – signed an agreement to transfer organic fertilizer production technology with Korean partners.



On 23/01/2019, the Joint Venture Agreement Signing ceremony of Vina Hyosung OnB was held successfully. It was also considered as an important milestone in this long-term cooperating relationship between Vinacafe Fertilizer JSC (Vietnam) and Hyosung OnB (Korea). As expected, the total capital investment will increase to 200 billion VND

with the production model following international standards. In this project, Vinacafe Fertilizer JSC will take charge in producing and distributing processes based on the rich experiences in Vietnam fertilizer market. As for Hyosung OnB, they will be working as technology consultant unit. Cooperating with Vinacafe Fertilizer will be a foundation to expand Hyosung OnB to other Asian countries such as Laos and Cambodia.

03 GRAND-OPENING OF ROOFTOP SOLAR SYSTEM

On January 4th, 2019, Skylight Power, a joint venture between BCG Energy and Indefol, has celebrated the Grand Opening Ceremony for its first 1 MW rooftop solar system installed at Dinsen's factory in Long An Province. Regarding this project, Skylight Power has worked closely with reliable partners such as GLZ (Germany) and Indefol for construction solutions, Adidas for coordination, and HD Bank for financing.

This is the largest rooftop solar project installed for an apparel factory and the second largest project among factories in general across Vietnam. The completion of 1 MW rooftop solar system at Dinsen in Long An Province gives the company a positive momentum to deploy another 5.4 MW for other factories located in Vietnam and Cambodia until. As a result, Dinsen will earn significant savings from its electricity bill for the next 20 years. With a total investment of more than 7 million USD, this project is carried out with Australian solar standards and European quality assurance in mind. By co-launching the first rooftop solar system, BCG Energy and Indefol are looking forward to establishing a modern and reasonable solar energy model which is capable of optimizing construction area for maximum returns and could be applied to both industrial plants and residential households.

04 KING CROWN VILLAGE GROUNDBREAKING CEREMONY

On January 16th, 2019, King Crown Village, a high-class real estate project developed by Bamboo Capital Group (BCG), has officially broken ground. With a total investment of up to 1,400 billion VND, King Crown Village, which also happens to be the very last riverfront villas project in Thao Dien area, is highly

praised for its investment security and effectiveness due to the project's location, construction and operation standards. The total land area is 9,125 m2 and comprised of 2 phases, in which 17 luxurious villas will be constructed in Phase 1, followed by a modern 25-storey building in Phase 2. BCG will participate as the project developer while the project owner is Sao Sang Saigon Joint Stock Company, which is also a subsidiary of Bamboo Capital Group.
