- a. Board of Directors:
  - Standing members: Not more than 10,000,000 VND/ person/month.

- b. Supervisory Board:
  - Members: Not more than 10,000,000 VND/person/month.

Total remuneration paid in 2019: **928,000,000 VND** (*Nine hundred and twenty-eight million Vietnam dong*).
